3. Public Comment on items not on the Agenda (2 minutes each)**None****4. Community Updates from any City, County, State or Federal representatives in attendance (5 minutes each)**

Ethan Weaver- Neighborhood Prosecutor: 41.18 update – continuing to work with LAPD, focusing on services first and arrests are a last resort. Reminder that LAPD cannot remove any belongings. It is a tricky situation since they have to weigh the jury's time with how best to successfully prosecute. The best tool is still Comprehensive Cleaning and Rapid Engagement (CARE/CARE+) clean ups. Wilcox Triangle issue is moving forward, and Mr. Weaver is optimistic.

LAPD Officer Cohen – Hollywood Volunteer Coordinator – currently rejuvenating the program of uniformed volunteers in the field, administrative help and computer/dispatch support. They have a community volunteer academy for training. There is no set time commitment for the volunteers.

Shannan Calland – CD-13 Field Deputy – CARE + clean up on Bronson and 101 completed on May 4th. Working with Hector Vega, CD13 Homelessness Deputy and SLO on continuing enforcement.

5. Dissemination of "Lock It - Hide It - Keep It" (LIHIKI) Safety Messaging

A) Discussion and update of possible methods of implementation and distribution to community on LIHIKI messaging, including, but not limited to, flyer/poster distribution, permanent signage in public spaces, LAPD Volunteer Corp live outreach, bus bench advertising

Brandi D'Amore brought up the limitations with the City's Attachment F

(https://codelibrary.amlegal.com/codes/los_angeles/latest/lamc/0-0-0-128154) which limits the use of paper posts and flyers. Griffith Park is amenable to permanent signage as is the Hollywood reservoir with Parks and Rec and the DWP. Officer Cohen thinks it would be effective to have a table set up in Hot Spot locations staffed with volunteers. Ms. D'Amore suggested perhaps Gelson's and Eastown, possibly CVS. She shared the City parameters on print distribution.

Reconsideration: The Board may reconsider and amend its action on items listed on the agenda if that reconsideration takes place before the end of the meeting at which it was considered or at the next regular meeting. The Board, on either of these two days, shall: (1) Make a Motion for Reconsideration and, if approved, (2) hear the matter and take an action. If the motion to reconsider an action is to be scheduled at the next meeting following the original action, then two items shall be placed on the agenda for that meeting: (1) A Motion for Reconsideration on the described matter and (2) a [Proposed] action should the motion to reconsider be approved. A Motion for Reconsideration can only be made by a Board member who has previously voted on the prevailing side of the original action taken. If a Motion for Reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Recording Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Ralph M. Brown Act.
