3. Public Comment on items not on the Agenda (2 minutes each)

Cindy Kane is part of a team that put together 2 in person safety fairs in 2018 and 2019 in West LA and 1 virtual fair in 2021. The 2022 Greater Los Angeles Safety and Preparedness Fair will take place on Sunday, November 13 at Exposition Park. The fair will offer handson CPR training, how to shut off utilities, etc. and they are asking all neighborhood councils in LA for financial support for the event.

Lionel Mares would like to increase the presence of mental health workers in the Hollywood area. He would like to see a System-wide Mental Assessment Response Team (SMART) in Hollywood.

4. Comments and Community Updates from any City, County, State or Federal representatives in attendance (5 minutes each)

David Ebner, Senor Lead Park Ranger, stated there was a suicide at the Griffith Park Observatory. No further details are available at this time. There have been more calls regarding exhausted hikers and tree falls in the park this month.

Shannon Callen from Council District (CD) 13 stated the start of the weekly Salvadorean American leader and educational fund through food distribution program for insecure families and gives a tentative location at Las Palmas Senior Center and Montecito Apartments

Chief Zipperman introduced the new LAFD Deputy of Operations West Bureau, Chief Richard Fields. Chief Fields discussed the need for community resiliency and planning, especially in the event of an emergency. Contact richard.fields@lacity.org

- 5. Discussion with Senior Lead Officer Brian White regarding community-based strategies for addressing crime and safety issues along Hollywood Boulevard
 - A) Discussion and possible motion to recommend Hollywood United Neighborhood Council sponsor or co-sponsor a community walk
 - Senior Lead Officer Brian White explained that the Entertainment District areas need more patronization from residents. He discussed a community walk. Committee and Brian White decide to make the walk an informal meeting on Hollywood Blvd (starting at Eastown, heading to Hollywood/Highland) not formally sponsored by HUNC so no motion is necessary.
- 6. Discussion of encampments near intersection of Hollywood and Wilton regarding use of street lights as power source and Americans with Disability Act (ADA) access for sidewalks
 - Shannan Calland discussed concern about a mushrooming encampment blocking the sidewalk at the intersection of Hollywood and Wilton. CD 13 in the process of coordinating movement forward on that encampment. Additionally it is working with the City and SLO regarding electricity being tapped.
