### 2. Approval of Minutes

Minutes were not available at the time of agenda item. Returns to the agenda item throughout the meeting were postponed until Chair Michael Connolly opted to not hear them at this meeting; will be reviewed at next.

3. Public Comment on items not on the Agenda (2 minutes each)

Bill Anderson went to speak on an item for CPAB; was advised to speak at the agenda item

Brandi D'Amore reminded Annika Guterman she is scheduled to attend August '22 meeting, and that if for some reason she cannot attend, she was asked to contact Commissioner Shaffer to obtain minutes to share with committee at next meeting. Tony Zimbardi is scheduled for September '22.

7. Discussion of committee mission and outreach goals for the year

Robert Morrison, speaking as president, would like each committee to set realistic outreach goals in recruiting people and getting the word out. Chair Michael Connolly would like to identify and pursue big goals that will help people and for everyone to feel safe, such as a drug and mental health treatment center in the area. Brandi D'Amore brought up that she invites people to the present at committee regularly and would like each member to contribute to bringing people/issues to the committee. Mr. Connolly will work to ensure everyone is participating and be the best chairperson he can be. Annika Guterman would like board to create/look at a central page on the website for information and contacts and the use of social media and help people connect.

8. Discussion of homeless encampments and fire safety

Robert Morrison brought up the power theft and how it can lead to fires and how it may be addressed. The topic was discussed. Brandi D'Amore shared contact info: LADWP watch commander 213-367-0352. LADWP camera monitoring 213-367-9111. LAPD Non-emergency number: 1-877-ASK-LAPD

LAFD Battalion Chief Nicholas Ferrari (Battalion 5, C platoon) spoke about their procedures, staff and equipment that they have to deal with encampment fires. He answered questions on reporting, the effectiveness of fire extinguishers for encampment fires (yes in most cases), if they can be used in anyway to get high (no), and shelf life of extinguishers.

Stakeholder David Gadd expressed concern with the homeless situation around Argyle and Franklin and the power theft and recent fires in that area.

9. Recap of 8/22 Community Police Advisory Board (CPAB) meeting

Brandi D'Amore gave an update. Stakeholder Bill Anderson added to the discussion by bringing up the topic at CPAB on the possibility of holding "active shooter training".
