4. Discussion and possible motion to take to full Board a letter from HUNC to appropriate City, County or publicly funded agencies involved with housing to consider leasing or purchasing the retirement home Hollywood Royale Gardens at 6054 Franklin Avenue 90028 for appropriate supportive housing use.

Brandi D'Amore presented the location which is currently a defunct senior facility. She gave background on the location and the type of facility. Her thoughts were that as it is already a fully constructed residential facility that could accommodate multiple people, the location should be considered for some sort of supportive housing. As an individual she has reached out to CD13 and HCIDLA, but nothing has moved forward. Also, attempts at contacting the owner have not been fruitful. She believes at this time that it requires a more formal request.

Angel Izard discussed that in her professional capacity as a Field Deputy for a council district she knows what needs to be done and all the parties to contact for such a letter. She agreed the location has possibility. She agreed to work on a draft for next Full Board.

Committee made suggestions regarding how it could be used: senior supportive housing, women experiencing "intimate partner violence" (IPV), teens, LGBTQ, veterans. A. Izard indicated that the type of housing structure may make it more temporary or transitional housing than permanent. She also indicated that the authorities would check the location for soundness and determine best fit.

B. D'Amore expressed some thoughts that people may have issue if used as a drug rehabilitation support facility due to the proximity to Cheremoya Elementary, and Thomas Valls echoed as families walk by there with their children. Joseph Hill added that he supports the suggestions and also defers to the agencies in charge making best decisions, noting the board can weigh in on the choice(s) made. Luis Saldivar supported. No public comment by attendees.

A. Izard will provide a draft to B. Cockrell by next board for review and possible edit.

He was advised that yes, it had, though some of those options are no longer available as City departments will not currently do specialized programs for individual groups. HUNC highlights government programs and webinars as they happen. Committee discussed some sort of event similar to the Renter Rights Forum of 2016, and some issues specific to events. B. D'Amore advised trying to present ideas for events at least three months out.

Angel Izard asked if non-government groups can present at board on their organization and events. B. D'Amore advised that they can be put on an agenda to make a brief presentation. B. Cockrell suggests that committee members bring these organizations to the attention of the board.
