- 6. Presentation with Question and Answer Session from Stratiscope (John Bwarie) regarding Hollywood Bowl, including but not limited to, neighborhood traffic implications and protocols on concert nights; follow-up from Hollywood Dell Civic Association meeting information

Mr. John Bwarie Informed the committee that his company is in the process of installing and streamlining a noise cancellation system at the Hollywood Bowl out of consideration for the surrounding homeowners.

He advised the board that Hollywood Bowl is working on mitigating traffic closures to prevent bottlenecking on surrounding roads. He made the distinction between so-called 'soft closures' by traffic police as distinct from full closures (and when each is warranted); advised that Uber and Lyft vehicles can be suspended from the area to avoid excessive congestion; acknowledged complaints concerning bus parking issues, and notified us that the Hollywood Dell is in the process of performing a traffic study for the area.

Ms. D'Amore asked follow-up questions regarding bass levels during performances and additional traffic concerns including the addition of a Traffic Control Officer (TCO) at the southbound 101 offramp at Vine; she requested that Mr. Bwarie make another appearance in this committee in the next quarter for updates, to which Mr. Bwarie agreed.

7. Roberto Rubalcaba, the homeless liaison for Caltrans, informed us that there are already several service requests on file for the fencing in question, and that CalTrans is aware that stronger measures than a mesh chain link fence will be required to restrict access to the area.

From the public, stakeholder Ernest Cornish and LAFD Chief Dean Zipperman both spoke on the dangers of power siphoning around the Argyle and Franklin overpass. Chief Zipperman informed the

committee of the Department of Transportation's existing customer service request system, should council members or other residents notice any safety concerns in this or any area. (csr.dot.ca.gov).

Brandi D'Amore pulled up a draft letter for committee to review. Upon discussion on the issue of fencing material, a clause was added to address. Additionally, discussion regarding outreach prompted by Mr. Rubalcaba indicating that it requires outreach for relocation before the fencing could be addressed resulted in a sentence in letter to address and support outreach.
