  - •Banitation report on how to add more wire trash bins around homeless encampments. Per motion, bins would be serviced every 3-4 days and located at encampments with 3-4 unhoused individuals.
  - •Dosh Nu, Legislative Director of CD4, joined the conversation. Josh provided the Committee information on the pilot of 10 new trash receptacles that will be piloted in CD4. These bins, though identified as wire by LA Sanitation, are in fact a new design. The pilot will operate for 90 Days at which point LASAN will provide Council a detailed feasibility and budget memo on the pilot.
  - MUNC T&W Committee raised several concerns including: flammability of cans; what is defined as "regular maintenance"; how to service encampments off major thoroughfares; how to track movement of camps and of bins in an efficient manner; and more. Josh will take these points back to CD4
  - •No community participants had questions.
  - •Brandi raised a motion to amend to consider questions raised by HUNC Members. Bianca agreed to write the CIS with adjustments, and the CIS should also be addressed to CD4 and CD13 directly.
