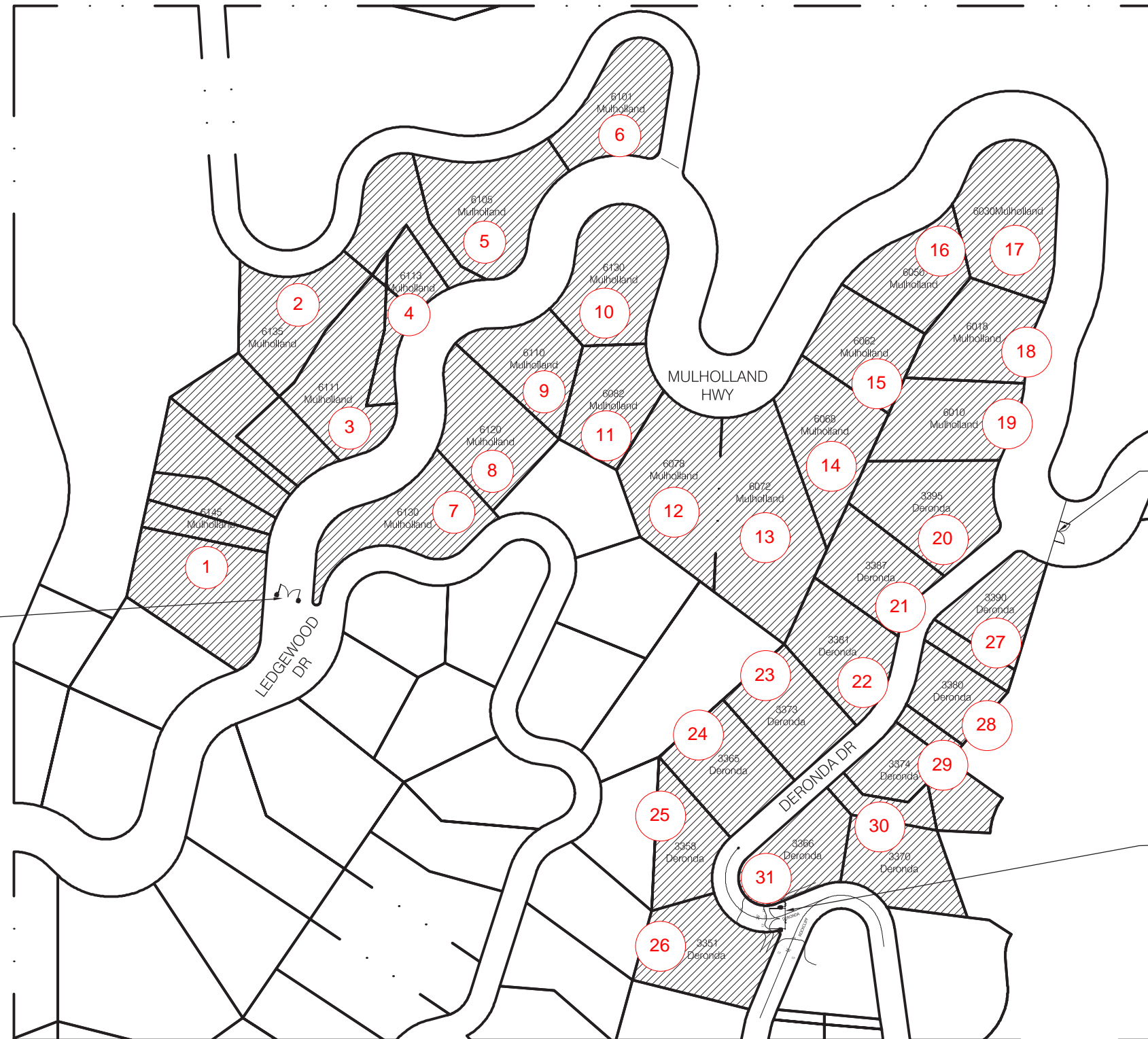

The community-proposed park would sit on an engineered platform that caps the open and below-grade eight-lane freeway. The proposed park will heal the gaping wound in the community caused by the highway's construction by creating new street-level connections between neighborhoods, reducing noise pollution, filtering emissions from the highway beneath the cap, reducing the urban heat island effect, creating new recreation opportunities, adding green space in a disadvantaged community that lacks park access, engaging in workforce development activities, and supporting housing equity. 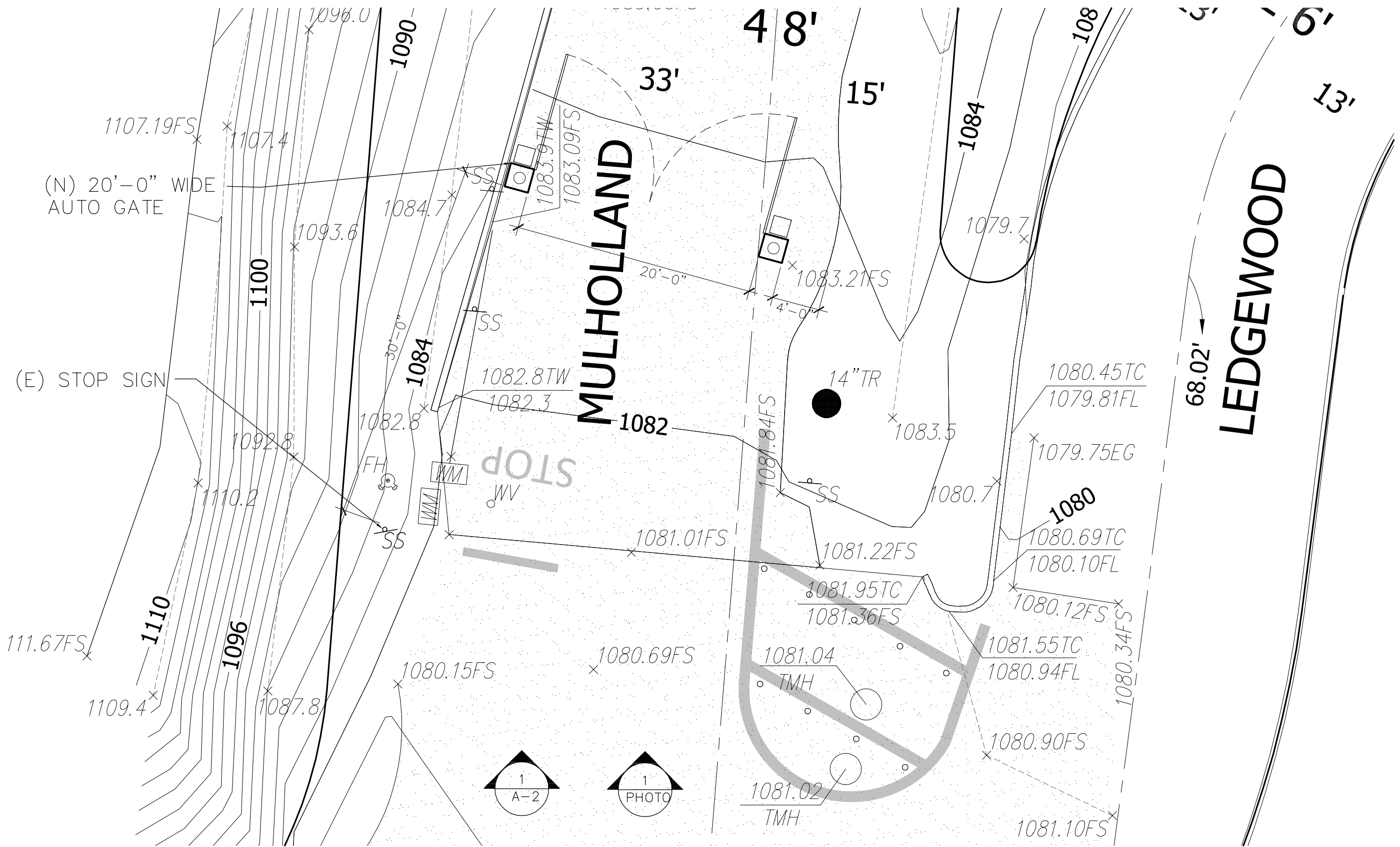

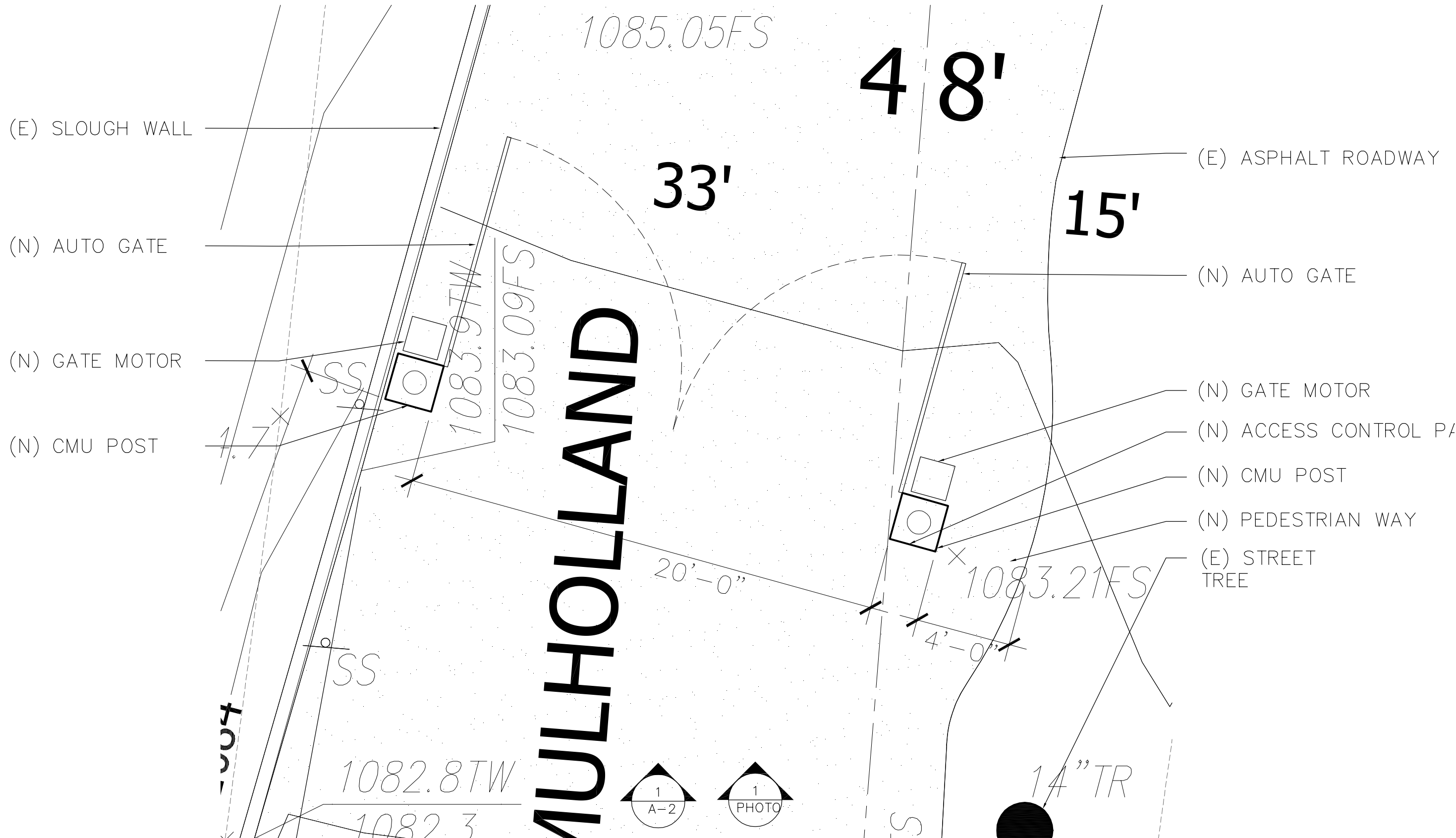

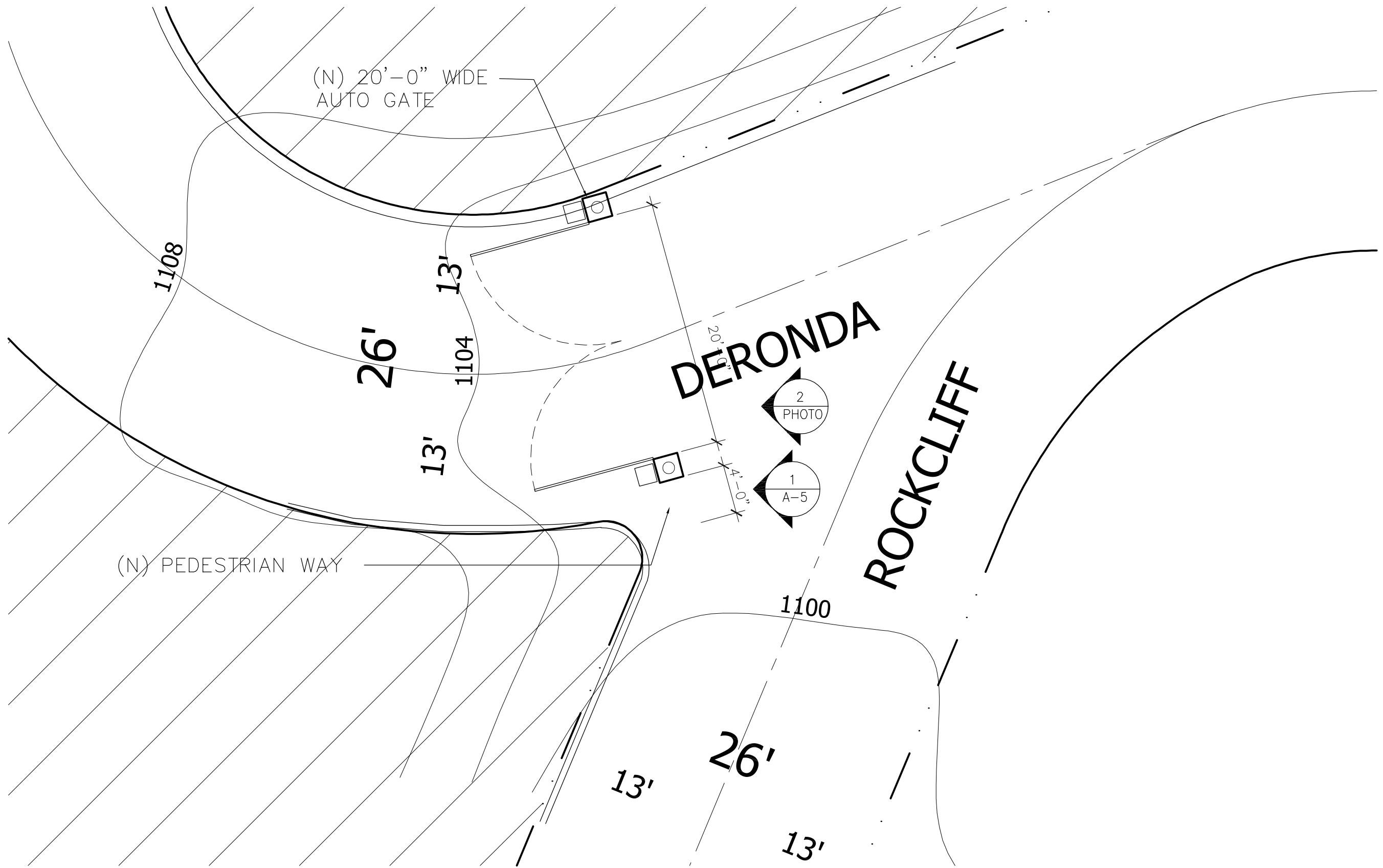

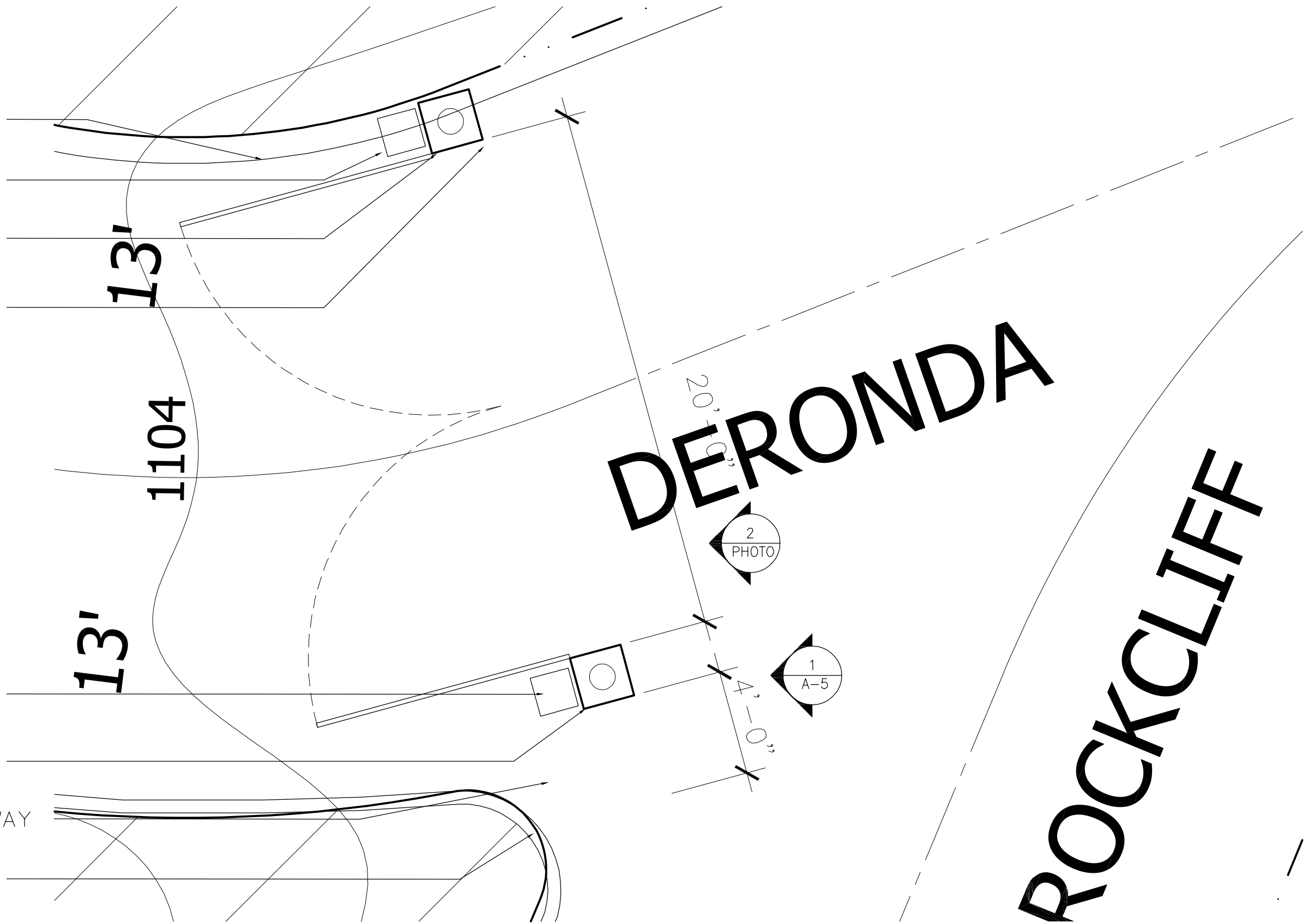

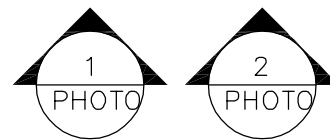

Dear Hollywood United Neighborhood Council,

We represent the property owners from 6010-6145 Mulholland Hwy. and 3351-3395 Deronda Dr. who are requesting a letter of support to install automobile gates at the intersections of Mulholland Hwy. and LedgeWOOD Dr., and also Deronda Dr. and Rockcliffe Dr. Our small road is significant as it is directly in front of Los Angeles's most popular landmark, the Hollywood sign. A Council Motion was adopted in 2010 and was under consideration by the City Engineer in 2011 per the attached exhibits, yet the adopted motion was never executed.

Because of our unique location, thousands of other Angelenos and tourists visit us every day. But our narrow, windy substandard dead-end roads do not end in a cul de sac and require a (minimum) 3-point turn at its terminus. In fact, that multi-point turn must be negotiated precisely where families go to capture the closest Hollywood sign selfie.

There is substantial documentation in the form of photographs, videos, and LADOT parking violation logs validating the threat to public safety. There have been instances where fire trucks and ambulances have been unable to access residents' homes and Griffith Park in emergency situations.

These traffic entanglements present a significant hazard to life. Backed up cars delay fire, medical, hiker-rescue, police and ranger response to emergencies that occur at this popular location in a Very High Severity Fire Zone. The amount of automobile traffic has increased enormously over the past year and is posing a significant public safety issue that needs to be addressed.

Attempting to mitigate the danger, we often position plastic road barriers and cones to discourage unknowing drivers from these hazards. While they look unprofessional, we have found that the barriers can be effective at mitigating traffic jams and blocking of ingress and egress. The residents do not in any way want to prevent or limit pedestrian access the beloved Griffith Park and Hollywood sign, however automobile traffic is posing a significant safety concern.

A more permanent solution is needed by all. We believe, and our actions have shown, that a gate restricting vehicle access to authorized vehicle only (residents and city/service vehicles) would be the most efficient and effective way to restore safety for everyone in the area.

For the benefit and safety of the police, fire department, parking enforcement, Park Rangers, tourists and residents, we encourage the City Council to approve the installation of a automobile gates to eliminate the danger caused by traffic jams in front of the Hollywood Sign.

COMMUNICATION FROM CHAIR, PUBLIC WORKS COMMITTEE relative to the temporarily closure of Ledgewood Drive at the intersection of Mulholland Highway for public safety reasons.

Recommendations for Council action, pursuant to Motion (LaBonge – Huizar):

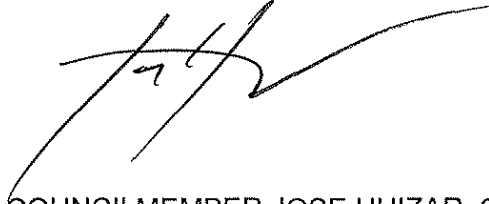
1. INSTRUCT the City Engineer and the Department of Transportation to report to the Public Works Committee with recommendations and the process necessary to temporarily close Ledgewood Drive at the intersection of Mulholland Highway for public safety.
2. INSTRUCT the City Engineer and/or his staff to solicit input from the local Hollywoodland Homeowners Association on its position of the proposed gate.
3. INSTRUCT the City Engineer to close the street entrance to Mulholland Highway at Ledgewood Drive pursuant to Section 21101.4 of the State Vehicle Code for a period of 18 months, subject to the following:
 - A. That the gates to be installed to effectuate the closure of the area be done under a permit issued by the City Engineer in room 4601-1 approved by the Fire Department.
 - B. That the gates will be installed by the residents at no cost to the City.
 - C. That the keys to the installed gates be provided to all adjoining property owners and affected City department and public utility companies.
 - D. That routine clean up of the closed area be provided by the adjoining property owners and/or residents.
 - E. That the petitioners agree to remove the gates/fences at the termination of the allowed closure period.
 - F. That the gate for walking access to dirt Mulholland be accessible to walkers/hikers/runners to Griffith Park and Mt. Lee Road from dawn until dusk - similar to other Recreation and Park operational hours.
4. FIND that this action is similar to a minor vacation and is categorically exempt from the California Environmental Quality Act of 1970 pursuant to Article VII, Class 5(3) of the City's Environmental Guidelines.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

SUMMARY

On September 22, 2010, the Public Works Committee Chair considered a Motion (LaBonge – Huizar) relative to the temporarily closure of Ledgewood Drive at the intersection of Mulholland Highway for public safety reasons. After consideration and having provided an opportunity for public comment, the Committee Chair moved to recommend approval of the recommendation as contained in this report. This matter is now submitted to Council for its consideration.

Subject: Temporary Closure of Mulholland Hwy between Ledgewood Drive and Woodview Drive

This office is considering a request from the Fourth Council District to temporarily close the above-referenced street for 18 months pursuant to State Vehicle Code Section 21101.4. The enclosed sketch indicates the area requested to be closed. No environmental studies have been prepared at this time.

The closure would be accomplished by either fencing of the street or by installation of gates and/or security guards at the entrance.

Referrals have been sent to government agencies for their input on the requested closure to ascertain any effect of this temporary closure.
