3. Comments on items not on the Agenda

Brian Dyer (Area 3 Rep on HHWNC, but not representing that NC) stated that he is against the Hollywood Central Park, because he believes there will be no affordable housing in the area, and developers have driven the price of the real estate surrounding the likely perimeter of the park to personally benefit from appreciation after the park is completed. He spoke about conflict of interest with the last Executive Director, Laurie Goldman and the developers who are purchasing land in the area of the proposed park. Additionally, he spoke about the building planned on SE corner of Cahuenga and Franklin at the former Shell Oil station is proposed at 30 stories and may block Sign view from surrounding businesses and housing, and will create more traffic congestion.

Brandi D'Amore cited multiple agenda items that require HUNC members to get City Attorney ruling on conflicts of interest, and that multiple members did not complete their planning training.

Government comment

Anais Gonzalez, field deputy, and Kalie Jansen, Homelessness Deputy, from CD13 stated there will be powerwashing of streets. To deal with the 90 day delay on street lighting, first create a 311 request and share the service request number by email to Anais.Gonzalez@lacity.org.

There are city grants available to non profits through CD13 for homeless services such as showers, etc.

4. Presentation by Andrew Ruddick, discussion of the removal of the Donald J Trump star on WALK OF FAME, and possible motion to move letter to Board for consideration.

Letter to be considered:

For the consideration of the Hollywood United Neighborhood Council to call for and support immediate efforts of CD13 and the Los Angeles City Council to remove Donald Trump's name found on a star on the Hollywood Walk of Fame, located at 6801 Hollywood Blvd. because:

- 1. Donald Trump's unprecedented history and conduct are unworthy of recognition on the Hollywood Walk of Fame, a city-sanctioned, historical cultural monument, and the plaque bearing Trump's name does not reflect the pro-democracy values of the City of Los Angeles.
- 2. The repeated vandalism and defacement of the star has demonstrated longstanding, adverse public reaction to the honorific located on the public right of way.
- 3. The City of Los Angeles holds ultimate authority in its jurisdiction over property, including the Hollywood Walk of Fame, on its sidewalk.

8. Discussion and review of letter provided by Steve Alper in support of installing automobile gate at intersection of Mulholland Hwy and Ledgewood Dr, Deronda & Rockcliff. with motion to move to Board for consideration.

Council File 10-1392 from 2010 passed allowing temporary gate for up to 18 months at Ledgewood & Mulholland, a dead end.

Derek Flynn, presenter, with Steve Alper, property owner

Derek Flynn sought out HUNC support of concept for temporary automatic, vehicle gate built at Rockcliff & Deronda as well as Ledgewood & Mullholland allowing for pedestrian and bicycle access, that is constructed fully at property owners' expense, who also absorb the costs of maintenance, and liabilitity insurance.

Overall costs estimated as \$40,000.00 for both gates.

Bureau of Engineering suggested acquiring Councilmember CD4, HOA and NC support. Derek Flynn stated that he has acquired Beachwood Canyon Neighborhood Association and is working on acquiring Hollywoodland Homeowners Association's support. Missy Kelly, President of BCNA, has stated that BCNA supports the location and adoption of the gates.

Jim Van Dusen wishes the City to continue to offer consistent parking enforcement in the area.

Sheila Irani wanted assurances that 100 percent or 31 total property owners behind the two gates will approve and adopt a common maintenance agreement.

Derek Flynn agreed to come back to board when the signatures of all property owners have been gathered to show support that they will pay for the gate and its maintenance and will adopt a common maintenance agreement. They will also secure the HHA support and support from CD4.

Motion Made: Discussion and review in support of the concept of installing temporary automobile gate at intersection of Mulholland Hwy and Ledgewood Dr, Deronda & Rockcliff. with motion to move to Board for consideration, provided the presenter have one hundred percent buy in by the property owners inside the gated areas in question, and support from LADOT for continued parking enforcement inside and outside the gates.
